Lauren Burm Senior Director, External Relations Parallel

Lauren serves as Senior Director for External Affairs at Parallel, which is the parent company to NETA - a Brookline medical and recreational cannabis dispensary. In her role, Lauren oversees all state and local government affairs and external communications.

Prior to joining the cannabis industry, Lauren was the Head of Public Affairs, Communications and Sustainability at Ørsted North America, which is the largest developer of offshore wind farms in the world.
